MOB 1.1.20 Complete Streets Policy

Escambia County recognizes the strong connection between land use and transportation and believes that providing a network of Complete Streets is vital to the sustainability of the County and its people. Implementation of Complete Streets is a cost-effective way of providing balance to the existing transportation network and will improve the county's ability to serve all travel modes regardless of age or ability, including pedestrians, bicyclists and motorists.

The implementation of a Complete Streets Policy will support economic development within the county by enhancing safety of all travel modes, maximizing the efficiency of vehicular movement, expanding connectivity and improving the overall travel experience.

The entire transportation network will be subject to the Complete Streets Policy including new location construction as well as modification and maintenance of the existing system. This Complete Streets approach will be viewed in a context sensitive manner with an emphasis on cost efficiency. The County will, to its greatest extent feasible, incorporate Complete Streets concepts on all future transportation improvements from planning through construction.
